160/16 APOLOGIES

163/16 SECTION 137 APPLICATIONS FOR FINANCIAL ASSISTANCE

164/16 CITY CENTRE PARTNERSHIP UPDATE (CCP)

The Town Clerk reported that the final documents had been prepared under the Partnership Scheme. These were the strategy document, the action plan and the terms of reference for the Partnership Board. These would soon be publicly available.

The Town Clerk also reported that the first Bangor Strategic Partnership Board Meeting would be held on Friday 10th February and the Council would be represented by the Mayor, Deputy Mayor the Chair of the Management Group John Wynn Jones and the Town Clerk.

165/16 TOWN CLERK'S REPORT – BUDGET FOR 2017/2018

The Town Clerk presented the budget report and responded to questions by Members on the various headings as follows :-

1) Review of Council Prices and Charges

RESOLVED:-

- (i) to approve the prices in the Penrhyn Hall as indicated in the Town Clerk's Report with the exception of a reduction for local groups and charities, £25, £33 and £42 for 1, 2 and 3 sessions;
- (ii) to increase annual rental charges for the Pier Kiosks as set out in the Report;
- (iii) that the Pier entrance prices should remain the same; and
- (iv) to implement the 2016 increase the car park price as indicated in the report;

2) Works at the Pier

Members noted the current position with regards to the capital works to be undertaken. Day to day management and maintenance issues were discussed and it was noted that a new policy was required on memorial benches & plaques – as these had been stopped.

In accordance with the Internal Auditor's advice, it was **RESOLVED** to reaffirm that the greater part of the Council's Capital Reserve would be used for Pier Renovation works.

3) Other Property Matters

Members noted the Town Clerk's concern at the coastal erosion that was threatening the boundary wall at the Pier Master's house and that works would be undertaken to address this.

4) Penrhyn Hall

Members noted the works at Penrhyn Hall, including kitchen refurbishments, and installation of audio-visual equipment in the Hall further decor work was required. It was noted that the Mayor's Parlour had been decorated but needed further updating.

5) Woodland Maintenance.

Members noted the concern regarding the condition of the two areas of woodland in the Council's ownership – Menai Woods and Penrhyn Arms Woods – and that work needed to be carried out over the course of the next 2/3 years to make the areas safe.

6) Council Offices

The Town Clerk reported various maintenance issues to be addressed including a collapsed sewer. The Town Clerk's report highlighted the concern expressed about the lack of a One Stop Shop, as Llys Gwynedd was now on limited opening hours.

RESOLVED that the Town Clerk write to the Chief Executive at Gwynedd Council to request a One-Stop Shop in Bangor to deal with the multitude of enquiries which were now coming to the City Council's Office.

7) Open Spaces and Play Areas.

The current situation was noted and the Town Clerk was asked to look at the arrangements regarding the Ashley Jones Field tenancy.

8) Town Centre Regeneration Issues

It was noted that the City Centre Partnership funding was due to come to an end on 31 March 2017. Members were informed that funds had been set aside for the Bangor Branding Partnership Project.

9) Gwynedd Services

Members discussed the current situations with regard to devolved services, transfer of assets and the possibility of the City Council investing in these areas.

RESOLVED that a reserve fund of approximately £20,000 be set aside for contingency in this area.

10) Staffing

It was noted that the two temporary workers contracts would end soon. The Town Clerk wished to discuss with Members the future staffing requirements – particularly with regard to the Pier Restoration Project.

RESOLVED that the Staffing Panel be convened soon to discuss these issues.

Membership of the Staffing Panel was confirmed as Councillor John Wynn Jones (Chair), Derek Hainge, Mayor and Deputy Mayor, Chairman and Vice-Chairman of Finance and General Purposes Committee and Planning & Amenities Committee.

166/16 APPOINTMENT of AN INTERNAL AUDITOR for 2016/17

The Town Clerk reported that it was a regulation to formally appoint an Internal Auditor for the Council. The Internal Auditor for the last few years had been Mr John Dryhurst Roberts who in the Town Clerk's opinion had done an excellent job and he was subsequently recommended to continue for 2016/17.

RESOLVED that Mr John Roberts be appointed as the City Council's Internal Auditor for the year 2016/2017.

167/16 INVOICES FOR PAYMENT

It was reported that the invoices as detailed on the schedule totalling £20,003.39 had been approved. The invoices were available for any Member to see if necessary. **RESOLVED** that the payments be noted.

168/16 FINANCE - Third Quarter Accounts 2016/17

The Town Clerk presented the third quarter accounts for information and comment, it was noted that this would be the last report of the current financial year prior to the final accounts which would be detailed from 1st April.

RESOLVED to receive and approve the Accounts as set out in the report.

169/16 RISK ASSESSMENT REVIEW & CONTROL OF FINANCIAL SYSTEM

The Town Clerk presented the above document, which had been forwarded to Members, who considered its contents.

After questions and discussion it was **RESOLVED** to approve the Risk Assessment Review and the Review of Effectiveness of Internal Control System as presented in the document.

170/16 ESTIMATES OF INCOME & EXPENDITURE

The Town Clerk presented the detailed schedule of Estimates for 2017/2018

The Budget was reviewed page by page and the Town Clerk explained the figures set out under the various headings, highlighting the major items of expenditure necessary in the coming financial year.

RESOLVED to accept all the recommendations contained in the schedule of Budget Estimates with the addition of a contingency fund of approx. £20,000 for Service Provision and to combine the Grants budget and contributions to other organisations.

171/16 PRECEPT 2017/2018

It was **RESOLVED** that the recommendations contained in the Town Clerk's Budget Estimates regarding the precept be approved subject to: -

- 1) any Capital Expenditure be funded from the Capital Reserve Account;
 - 2) any under-spend from 2016/17 be allocated to Capital Reserves for the Pier and a new contingency fund for Services; and
 - 3) the Precept for 2017/2018 be £356,683.00.
