180/18 APOLOGIES

181/18 DECLARATION OF FINANCIAL INTEREST OR PERSONAL CONNECTION

Councillors J Wynn Jones and Les Day declared an interest in Item 183/18 Applications for Financial Assistance/Other donations within Budget.

182/18 SECTION 137 APPLICATIONS FOR FINANCIAL ASSISTANCE

The Town Clerk reported on applications that had been received and responded to several questions on the process, funding and details of each of the application.

RESOLVED : that the following organisations be granted the sums of :-

184/18 WELL BEING OF FUTURE GENERATIONS ACT 2015

The Town Clerk submitted a written report explaining the significance of the Local Public Services Board, their Local Well Being Plan and the requirements of the City Council to link its Annual Report to the aims and objectives of the Plan.

RESOLVED: that the Town Clerk's report be received and that a draft Annual Report be submitted to a future meeting for comment and approval.

185/18 PIER UPDATE

The Town Clerk reported progress at the Pier head and the rapid progress of the repair and refurbishment works. He also reported upon the financial position including figures for budget, commitments, projections and suppliers of goods and services. The current and projected expenditure schedules together with list of payees had been shared with and approved by the Financial Approvers in accordance with Standing Orders.

RESOLVED: that the report be received, noted and that the financial position be approved and figures noted.

186/18 FINANCE

a) **Invoices for Payment** - It was noted that invoices as detailed on the schedule totalling £3852.07 had been approved.
RESOLVED that the payments be noted.

b) **Third Quarter Accounts 2018/19** - The Town Clerk presented the Third Quarter Accounts for information and comment.

RESOLVED : the Accounts be received and noted as set out in the report.

187/18 RISK ASSESSMENT REVIEW & CONTROL OF FINANCIAL SYSTEM

The Town Clerk presented the above document, which had been circulated.

RESOLVED : that the Risk Assessment Review and the Review of Effectiveness of Internal Control System document be received and approved.

188/18 TOWN CLERK'S FINANCIAL REPORT – BUDGET FOR 2019/2020

The Town Clerk presented the budget report and responded to questions by Members on the various headings as follows:-

Review of Council Prices and Charges

RESOLVED:- to approve the prices of Penrhyn Hall hire as indicated in the Town Clerk's Report; rental charges for the Pier Kiosks as set out in the Report; and that the Pier entrance prices should remain the same; and the car park price as indicated in the report;

Works at the Pier

Members noted that the capital works had almost reached its completion (phases 1-4) and the allocated budget of £1.3M was likely to be exhausted by April.

The Town Clerk reported that there were two phases untouched and responded to questions as to whether the refurbishment of these phases (5 & 6) could be completed or delayed. The Town Clerk stated that an estimated fund of £360,000 would be required to complete the work based on the costs incurred in an earlier similar phase.

RESOLVED: that i) a Special Meeting of the Finance & General Purposes Committee be held on 18 February following Planning Committee to consider this matter and the future of the Pier, also that a Special Council be convened to ratify the decision of the Committee the same night; and ii) a decision on capital allocation as indicated in the budget book (£200,000) be delayed until a decision is arrived at

Operational Services

RESOLVED that funds be set aside for necessary works as contained in the report and budget schedules.

Staffing

It was noted that two seasonal temporary workers would be required to assist with the workload

RESOLVED that the Town Clerk assess requirements and be authorised to appoint two seasonal temporary workers in consultation with the Mayor, Deputy Mayor and Chair of the Staffing Panel.

189/18 ESTIMATES OF INCOME & EXPENDITURE

The Town Clerk presented the detailed schedule of Estimates for 2019/2020

The Budget was reviewed page by page and the Town Clerk explained the figures set out under the various headings, highlighting the major items of expenditure necessary in the coming financial year.

RESOLVED to accept all the recommendations contained in the schedule of Budget Estimates.

190/18 PRECEPT 2019/2020

RESOLVED : that the recommendations contained in the Schedule of Budget Estimates be approved subject to :-

- 1) any Capital Expenditure be funded from the Capital Reserve Account;
- 2) the Capital Reserve of £1.3m already allocated to the Pier Renovation Project be confirmed and ear-marked as such and the Town Clerk continues to inform and report to the City Council's Financial Approvers (in accordance with Financial Regulations) and Members with regard to updates, expenditure and approval of payment;
- 3) any under-spend from 2018/19 be allocated to General Reserves and new contingency costs; and
- 4) the Precept for 2019/2020 be £385,216.
