178/16 REVIEW OF THE ELECTORAL ARRANGEMENT FOR THE COUNTY OF GWYNEDD

The Town Clerk reported that the City Council had received notification from the Boundary Commission for Wales of the impending "Review of the Electoral Arrangement for Gwynedd". Any representation should be made by 31 May 2017.

179/16 PLANNING APPLICATIONS

RESOLVED: that the Gwynedd Planning Authority be advised that the City Council have the following observations to make on the applications listed below: -

C17/0070/11/LL Change of use of the vacant floors above the existing shops to provide two houses of multiple occupation with six bedrooms in each unit. 259 -263 High Street. **Objection of the grounds of over-development with 15 individual units proposed at this site. There would be difficulty of access both for residents and for emergency services. There are already too many bedsits in the City.**

C17/0084/11/LL Demolition of existing social club building and erection of a three storey building with shop (including cafe, fascia signage and ATM) on ground floor and 10 one bedrooomed flats above (re-submission of application ref. C16/0157/11/LL) Maesgeirchen Social Club, 90, Penrhyn Avenue. **Objection. Building proposed is too large and overbearing on existing mainly residential properties. The positioning of a supermarket opposite older persons bungalows would cause noise nuisance and attract youths and potentially anti-social behaviour. A recent survey showed no desire for a supermarket in the vicinity. Also the site is designated as amenity land not residential/retail.**

C17/0097/11/LL Amended plans for the installation of a rear dormer window and windows in the gables to convert the loftspace. 17, Trefonwys. **No objection.**

C17/0106/11/HY Siting of 4 signs including 2 stack signs and 2 free standing swing signs. Junction to Plas y Coed, Llandegai Road. **Objections. The signs are too large, and too numerous on this busy junction.**

C17/0146/11/HY Alterations to existing dwelling to form a self-contained 2 bedroomed flat at lower ground floor level (with separate entrance) together with internal alterations upper storeys and new external stepped access to the rear yard. Bodlondeb, 50 , Holyhead Road. **No objection.**

C17/0148/11/LL Erection of a single storey side and front extension, 4 Min y Ddol, Maesgeirchen. **No objection.**

C17/0160/11/LL Change of use of the third floor of the building to provide three self-contained flats and installation of dormer windows to the rear. 259 – 263 High Street. **Objection of the grounds of over-development with 15 individual units proposed at this site. There would be difficulty of access both for residents and for emergency services.**

Councillor Mrs J Marshall, as a Member of the Gwynedd Council Planning Committee, did not vote and took no part in the discussion on any of the above applications apart from the applications within her own Ward.
