119/19 PLANNING APPLICATIONS

RESOLVED: that the Gwynedd Planning Authority be advised that the City Council have the following observations to make on the applications listed below: -

C19/0948/11/LL Rear Extension so as to create an additional bedroom. Bryn Awel, Ffordd Deiniol. **Objection overdevelopment of the site and against the HMO Policy as stated in the Local Development Plan.**

The Town Clerk was asked to write to Gwynedd Council regarding their policy on extending current HMO's as the City Council's viewpoint was to reject these due to capacity issues with in the City.

The Town Clerk also to request a Gwynedd Planning Officer to attend a future meeting of the Council to explain the position and elaborate on the percentages policy in each ward.

C19/0987/11/LL Change of use from a shop (use class A1) into a café (use class A3) together with siting of an extractor fan. 234 High Street. **No objection.**

C19/0995/11/LL Removal of condition 3 re planning permission C19/0323/11/LL which states 2 units out of 8 to affordable units. 233 – 235 High Street **Objection on the grounds that there had been no material change to allow this removal of condition. There is an established need for affordable housing within Bangor and this permission was given with that in mind.**

C19/1012/11/CR Internal and external alterations to dwelling house, to include conversion of outbuilding to form part of the house. 6 Glandwr Road. **No objection.**

C19/1014/11/LL Conversion of outbuilding to form part of dwelling house. 6 Glandwr Road. **No objection.**

C19/1018/11/LL Change of use from furniture warehouse into a site for selling cars. The Pine Mine, Holyhead Road. **Objection on the grounds of highway safety as this site is on a very busy road and the proposed development would generate a dangerous access and egress to the site.**

120/19 HIGHWAY MATTERS -

Proposed Parking Restrictions – Arfon Area (Number12) 2019 – Bangor

RSOLVED: that an objection be lodged to the proposed restrictions as this was not a suitable solution to a very complex problem in the area and request that this be re-visited.

122/19 PIER UPDATE AND EXPENDITURE TO DATE

The Town Clerk reported that nearly all the work on the renovation project has now ceased, the only current piece of work still outstanding was the new steel that had been erected on Phase 4 which was yet to be lasted and painted.

The budget was virtually exhausted apart from re-saleable goods within the Council's ownership. The Town Clerk gave several options as to the proposed solutions including deferring any further work until the new budget for 2020/21. Members discussed the options in great detail and generally supported the preservation of the new steel that had been put in place.

- a) that the new steel in place on phase 3 be blasted and painted before all work stops and that an additional sum up to a maximum of £50,000 be put aside for this work from reserves, and
 - b) that all staff involved in the Restoration Project be thanked for their hard work and dedication in improving the lifespan and safety of the Pier.

Adroddodd Clerc y Dref fod bron y cyfan o'r gwaith ar y prosiect adfer wedi dod i ben bellach. Yr unig ddarn o waith oedd yn dal yn weddill oedd y dur newydd oedd wedi'i godi ar Gam 4 a oedd angen ei danio a'i beintio.

Roedd y gyllideb bron â dod i ben yn llwyr ar wahân i nwyddau ailwerthadwy o fewn perchnogaeth y Cyngor. Rhoddodd Clerc y Dref sawl opsiwn o ran y datrysiaid posibl yn cynnwys gohirio unrhyw waith pellach tan gyllideb newydd 2020/21.
