**C20/0705/11/DT** Extension above the garage. 12 Bryn Adda. **No objection.**

**C20/0706/11/CT** Maintenance work on trees located within the conservation area. Parc Tan y Fynwent. **No objection.**

**C20/0718/11/DT** Single storey rear extension. 40 Ffordd Glynne, Bangor. **No objection.**

**C20/0744/11/LL** Erection of a new dwelling together with associated works including parking spaces and alterations to the existing access. Tir ger Cliff Cottage. **Objection: The Council were opposed to this application as it is considered to be an overdevelopment of the site. Concerns were also expressed regarding the entrance and exit for vehicles onto this lane, which would increase the danger of traffic accidents.**

**C20/0754/11/RA** Discharge condition 12 (demolition method statement) and condition 16 (maintenance plan) of planning permission C18/0796/11/R3 together with an up dated bat survey. 182 Penrhos Road. **No objection.**
